ARTICLES OF INCORPORATION

We, the undersigned natural persons of the age of nineteen (19) or more, acting as incorporators under the Alaska Nonprofit Corporations Act, adopt the following Articles of Incorporation.

ARTICLE I

Name

The name of the corporation shall be The Northern Lights Council of Dancers, Incorporated.

ARTICLE II

Duration

The corporation shall exist perpetually.

ARTICLE III

Purpose

This corporation is organized to promote and perpetuate Square, Round, and Folk dancing and charitable fund raising, but principally to bear full responsibility for leasing and managing a dance hall facility.

ARTICLE IV

Registered Office and Registered Agent

The address of this corporation's initial registered office shall be P O Box 74702, Fairbanks, Alaska 99707, and the name of this corporation's initial registered agent at such address shall be Wendell R. Kaiser.

ARTICLE V

Members

The members of the corporation shall consist of six (6) dance clubs, which number may be increased by the formation of additional dance clubs who petition for and are accepted for membership.

ARTICLE VI

Directors

The number of directors constituting the initial board of directors of the corporation is six (6), and the names and addresses of the persons who are to serve as initial directors are as follows:

Each dance club holding membership in the corporation shall elect one (1) director to the Board of Directors.

The term of office of each director is for one (1) year.

Vacancies on the Board of Directors and directorships to be filled by reason of an increase in the number of directors shall be filled by the member club for which the vacancy exists.

ARTICLE VII

Election of Officers

The officers shall be elected by the directors, who shall first be elected by the members of the corporation.

ARTICLE VIII

Dissolution

Upon dissolution of the corporation, those assets described in AS 10.20.295(5) shall, if a plan of distribution is not then in effect, be distributed equally to the member clubs.

ARTICLE IX

Amendments

These articles may be amended in the manner provided by statute at the time of amendment.
